- 4.2 Board Member Comment

Chairman and Board Member comments included the following:

 Chairman Gary Jacobs asked the HTH Officers to provide the Board with staff retention data, and how HTH compares to local and national averages. Chief Learning Officer Janie Griswold shared a presentation that demonstrated the retention rates ranging from 2018 - 2022. A Teacher Retention Survey conducted in Spring 2022 leads HTH to anticipate a

- similar retention rate as 2021, in the 80% range. Janie also provided various actions that HTH is taking in order to improve retention and recruitment.
- Board Secretary Héctor Pérez commented that there does not appear to be much data available to do a true comparison, which Janie Griswold confirmed.
- Gary Jacobs inquired about the timeline for the implementation of a new HR Payroll system. Chief Financial Officer Jackie Chen shared that a new software system, intended to assist with human resources and financial reporting needs, will be selected and presented to the Board by December 2022. The business office will present an implementation plan to the Board in the first months of 2023.
- Gary Jacobs inquired whether the HTH Bargaining team had yet passed all sunshined proposals to the HTEC Bargaining team. General Counsel Patrick Frost confirmed that HTH has passed on all of their 13 initial proposals, and the bargaining teams have been able to reach Tentative Agreements on 4 proposals.
- Board Trustee Albert Lin added there has been mention of feelings of delay from HTH in the bargaining process. Albert asked HTH to look into why that is, and what can be done to be as responsive as possible. Patrick Frost confirmed that HTH is working diligently on their bargaining proposals to be able to reach a collective agreement.
- Gary Jacobs asked how the hiring process and teacher recruitment is progressing. Interim Director of Operations Isaac Jones responded that Interim Director of Operations Julie Holmes and himself have been attending several job fairs and connecting with local universities. These recruitment activities established that HTH is facing similar staffing difficulties as other local school districts. Human Resources has received a healthy number of applicants, and hiring bonanzas at each school and have begun hiring for next year.
- Board Trustee Lida Rafia asked if HTH can provide the Board with salary schedules and comparisons between SDUSD and other school districts.
 Janie Griswold confirmed.
- Gary Jacobs highlighted that HTH recently asked the community to help vote on charter school legislation that would help HTH schools be "held harmless" and therefore recoup funds due to reduced pandemic attendance that are currently not available to charter schools. Gary also mentioned that Governor Newsom's May Revised Budget is forthcoming, and will likely provide further financial assistance that will allow HTH to better fund the organization.
- Albert Lin inquired if these two items are greatest opportunities to help HTH financially. Gary Jacobs affirmed, stating that Held Harmless would dramatically help charter schools who are currently excluded from this significant funding.
- Albert Lin asked how else HTH can make the community aware that they
 need this support. Interim CEO Kaleb Rashad responded that HTH is
 collaborating with teaching teams who have inquired about specific ideas
 on what to do and how to take action. HTH is also working with CCSA to
 identify what specific legislation information should be distributed to the
 community when they ask for the community's help in advocating for our

- needs to legislators.
- Héctor Pérez stated that this community email could present comparative or projected gains.
- Kaleb Rashad shared that HTEC has been very helpful in advocating for support.
- Albert Lin asked if there is any guidance from the state level surrounding
 actions they are taking to address inflation and COLA. Albert asked HTH to
 host a review of salary frameworks and cost of living ratios to best
 understand the effects of increasing COLA. Kaleb Rashad provided that
 HTH needs both the state's help to increase funding, and a way to stably
 rework finances to direct funds where they are most needed in the
 organization.

Open session was suspended at 7:07 p.m. Closed session convened at 7:07 p.m. and adjourned at 7:59 p.m. Open session re-convened at 7:59 p.m. A roll call was taken at this time to re-confirm a quorum.
