Chairman and Board Member comments included the following:

 Board Chairman Gary Jacobs congratulated both teams on reaching the collective bargaining tentative agreement.

- Gary Jacobs announced that the Board will resume in-person Board meetings starting in March, and more details will be shared once the details are finalized.
- Gary Jacobs asked the Officers for an update on collective bargaining. General Counsel Patrick Frost shared that HTH and HTEC (certificated unit) have reached a tentative agreement for the full CBA. The Board will vote on the ratification of the tentative agreements later tonight, and the Collective will bring the agreement for ratification to their members in February. HTH is excited about this news and looks forward to moving forward with our union partners. Patrick also provided an update on the status of the bargaining process with HTEC Classified unit. At present, HTH is awaiting the initial proposals from the union, and the step to follow would be to sunshine these proposals to the Board.
- Gary Jacobs asked the Officers to provide an update on Transitional Kindergarten (TK). Janie Griswold commented that HTH is excited and interested in the possibility, and is establishing how to move forward with the current California state funding being provided to schools to implement TK, in addition to complying with facilities and staffing requirements.
- Board Trustee Albert Lin expressed his appreciation for the genuine effort by both bargaining teams to reach this tentative agreement, all while preserving the shared goal of improving the well being of the school and students. Albert invited the community to engage and connect with public official representatives to prioritize funding for education.
- Board Secretary Héctor Pérez echoed the celebration of the tentative agreement, and asked the community to consider how HTH can collectively voice our financial needs to our government, while continuing to seek financial support through grants.
- Board Trustee Lida Rafia congratulated the bargaining teams on this milestone, and hopes that this continued passion and commitment can be put towards our students' success.

Open session was suspended at 6:52 p.m. Closed session convened at 6:53 p.m. and adjourned at 8:21 p.m. Open session re-convened at 8:21 p.m. A roll call was taken at this time to re-confirm a quorum.
