About Our School

His experience as a leader and lifelong learner has been collected from his service in a number of enrollment, recruitment and post-secondary counseling leadership roles. A native of Seattle, Washington, Joseph earned his Bachelor of Arts degree from Washington State University and a master's degree in educational leadership from the HTH Graduate School of Education. When he's not engaged in the work, Joseph loves spending time with his wife and daughter, traveling, enjoying live music, creative writing, and enjoying San Diego.

Launched by an industry and educator coalition, High Tech High North County is designed to immerse students in a rigorous learning environment that engages their interests in the fields of math, science and engineering. High Tech High North County is a small, diverse learning community with a current enrollment of 411 students. HTHNC is founded on four design principles: equity, personalization, authentic work, and collaborative design. Innovative features include performance-based assessment, daily shared planning time for staff, state-of-the-art technical facilities for project-based learning, internships for students, and close links to the high tech workplace. The mission of HTH is to provide students with rigorous and relevant academic and workplace skills, preparing its graduates for rewarding lives in our increasingly technological society. High Tech High North County was built on a culture of community and personalization. We recognize that students with different learning needs, family backgrounds and personal interests require individually crafted support and planning. The student-faculty ratio at High Tech High North County is 23:1, and each student has an advisor who remains constant throughout the four years of school. High Tech High North County's curriculum is built upon real project work by situating students directly in workplaces, by bringing industry specialists into the school, and by fostering relationships between students and mentors. A coherent intellectual mission is reflected in the emphasis on the use of technology as a tool and the relationship of learning to careers. High Tech High North County believes that all students and adults should be treated with dignity and respect. This culture embraces and promotes a positive learning environment where all students abide by a code of conduct.

School Facility Conditions and Planned Improvements

HTHNC is a 46,426 square foot, two-story, high school built in 2009. The building is in excellent condition, with maintenance and custodial services provided by on-site staff. There are no maintenance needs beyond those that are routine for a school of this size. A 157 Kw photovoltaic solar system was completed in December of 2016 on the adjacent HTENC Building. This system, shared by HTENC, will greatly reduce the school's energy bill. The two large HVAC package units on the roof were replaced in January of 2020.

Professional Development

Professional development is an important facet at HTH schools. Dedicated time to hone one's teaching practice is incorporated into each teacher's work year, per their contract, and takes multiple forms:

- **Staff days:** Veteran staff return to school 8 days before school starts. There are also 5 staff days throughout the year plus 2 additional staff days at the end of the year. Staff days are an opportunity for teachers to learn from one another, built on the belief that "we have a lot of expert knowledge right here in our building."
- **New Teacher Odyssey:** Prior to the 8 staff days for veteran teachers, teachers new to HTH participate in a 5 day "Odyssey." During Odyssey, teachers experience project based learning as learners themselves, engaging in a Project "Slice"; a shortened version of a project with the key components.
- **Weekly Meetings:** Teachers arrive one hour before school starts to engage in collegial dialogue. Meetings occurs at least 3 days per month. In practice, these meetings serve as a theoretical context for veteran and new teachers to reflect on and refine their day-to-day practice. These meeting enable teachers to collaborate, analyze data, plan projects, and tackle dilemmas. Teachers also meet for extended half-day professional development in the afternoon.

It is worth noting that, as part of the HTH charter management organization, HTH teachers receive additional professional development support through the HTH Credential Program and the HTH Graduate School of Education.
