### About Our School

David Gillingham is the Director of High Tech Middle Media Arts. He is extremely passionate about designing, making and exploring the unknown. He spent 3 years working as a low voltage electrician, during which time he developed a great adoration of building, tinkering, and problem solving. He believes that the universe is an untapped well of knowledge just waiting to be consumed and looks forward to inspiring that enthusiasm for learning in every student he encounters.

## 2024-25 School Description and Mission Statement

He came to HTM in May of 2011 and became the Extended Services Director. He began his first year teaching in 7th grade in 2013, teaching math and life science. His favorite project was when his students researched animals in captivity, designed Zoo enclosures for those animals and their natural habitats, and presented those designs to Architects at the San Diego Zoo. The next year, he taught 8th grade math and physics and was ecstatic to work with some of the same students. Building on their success from 7th grade, his students hosted an Air Pressure Carnival and constructed steel Marble Roller Coasters that demonstrated properties of motion. He also has co-directed the Summer Bridge Program for incoming 6th graders for the last 5 years. He then served two years as the Dean of Students at High Tech Middle Media Arts, where he supported the development of a positive school culture through fostering meaningful relationships. Now as the Director, Dave is constantly working with his colleagues to ensure all of our students have access to the highest quality education and best experience possible at HTMMA.

Before coming to High Tech High, David was the after school program director at Francis Parker Lower School, working there for 6 years, during which time he grew to understand the value of building relationships in an educational setting. David graduated Magna Cum Laude from National University in 2010 with a Bachelor's Degree in mathematics and later obtained his single subject teaching credential in mathematics and science from High Tech High Graduate School of Education. In the spring of 2017 David completed his Masters in Education in School Leadership through the High Tech High Graduate School of Education. David also recently completed his preliminary Administrative Credential through the San Diego County Office of Education. He has traveled Paris, Mexico, safaried in South Africa, and survived driving on the streets of Italy. In his free time, he enjoys boogie boarding at the beach, playing the drums and listening to music and working on his golf handicap!

### Mission Statement

Launched by an industry and educator coalition, High Tech Middle Media Arts is designed to immerse students in a rigorous learning environment that engages their interests in the fields of math, science and engineering. High Tech Middle Media Arts is a small, diverse learning community with a current enrollment of 339 students. HTMMA is founded on four design principles: equity, personalization, authentic work, and collaborative design. Innovative features include performance-based assessment, daily shared planning time for staff, state-of-the-art technical facilities for project-based learning, internships for students, and close links to the high tech workplace. The mission of HTH is to provide students with rigorous and relevant academic and workplace skills, preparing its graduates for rewarding lives in our increasingly technological society. High Tech Middle Media Arts was built on a culture of community and personalization. We recognize that students with different learning needs, family backgrounds and personal interests require individually crafted support and planning. The student-faculty ratio at High Tech Middle Media Arts is 22:1, and each student has an advisor who remains constant throughout the four years of school. High Tech Middle Media Arts's curriculum is built upon real project work by situating students directly in workplaces, by bringing industry specialists into the school, and by fostering relationships between students and mentors. A coherent intellectual mission is reflected in the emphasis on the use of technology as a tool and the relationship of learning to careers. High Tech Middle Media Arts believes that all students and adults should be treated with dignity and respect. This culture embraces and promotes a positive learning environment where all students abide by a code of conduct.

HTMMA offers a fun yet challenging, technologically-rich, project-based learning environment for 6th to 8th graders. Diverse groups of students collaborate to solve problems, complete tasks, and CREATE. The walls boast student-crafted projects, and provide a small glimpse into the creative minds of our students and teachers. At HTMMA, teachers design the project-based curriculum. They focus on personalization, tapping into student interests to make learning relevant and developing 21st century skills such as critical thinking, effective communication, deep content knowledge, collaboration, and creativity. Each year, students team with a humanities teacher, a math/science teacher, and a Fine Art, Makers, or Multimedia teacher.

## School Facility Conditions and Planned Improvements

HTMMA occupies the second floor of a 91,140 square foot, three story building that was originally built in 1967+/-, but was completely renovated in 2005. The building is in excellent condition, with maintenance and custodial services provided by on-site staff. There are no maintenance needs beyond those that are routine for a school of this size. A 70 Kw photovoltaic system was added to the roof in 2014. LED lighting and other energy upgrades were implemented in 2016.

## Fiscal Year 2023-24 Types of Services Funded

High Tech Middle Media Arts offers a preparatory curriculum that supports students in finding success in the UC A-G coursework that they will take in high school in preparation for college admission. This includes an integrated math and science class, a humanities class, an arts class (exploratory), advisory and x block (electives) daily. During these courses, all students have access to technology to complete their school work. During X Block, students have opportunities to get involved with activities such as technology and multimedia, football, soccer, rock climbing, exploring other cultures, and academic coaching for struggling students. In addition, students are able to go on field trips and attend camps and retreats. HTMMA also offers a comprehensive before and after school program.

## Professional Development

Professional development is an important facet at HTH schools. Dedicated time to hone one's teaching practice is incorporated into each teacher's work year, per their contract, and takes multiple forms:

## Professional Development

- Staff days: Veteran staff return to school 8 days before school starts. There are also 5 staff days throughout the year plus 2 additional staff days at the end of the year. Staff days are an opportunity for teachers to learn from one another, built on the belief that “we have a lot of expert knowledge right here in our building.”
- New Teacher Odyssey: Prior to the 8 staff days for veteran teachers, teachers new to HTH participate in a 5 day “Odyssey.” During Odyssey, teachers experience project based learning as learners themselves, engaging in a Project “Slice”; a shortened version of a project with the key components.
- Weekly Meetings: Teachers arrive one hour before school starts to engage in collegial dialogue each day. In addition, they attend afternoon professional development meetings at least 3 days per month. In practice, these meetings serve as a theoretical context for veteran and new teachers to reflect on and refine their day-to-day practice. These meetings enable teachers to collaborate, analyze data, plan projects, and tackle dilemmas. Teachers also meet for extended half-day professional development in the afternoon.

It is worth noting that, as part of the HTH charter management organization, HTH teachers receive additional professional development support through the HTH Credential Program and the HTH Graduate School of Education.
