About Our School

Jade White is the Director of High Tech High International. She has been a member of the HTH community since 2004. She taught math and physics at HTH for 13 years before transitioning to the role of Director at HTHI. As an educator, Jade believes in creating an equitable and collaborative experience where students explore the world around them via hands-on projects and inquiry.

HTHI is a public charter school which draws upon the diversity of San Diego through a random lottery acceptance system. The

goal of High Tech High International is to offer a college preparatory, project-based learning environment to 9-12 grade students. Our work is guided by our four design principles: equity, personalization, authentic work and collaborative design.

Equity

High Tech High is an equity project. Teachers work actively to address inequities and help students reach their full potential. Our schools are intentionally diverse, enrolling students through a zip code-based lottery aimed at creating schools that are reflective of the communities we serve. Teachers recognize the value of having students from different backgrounds working together, and employ a variety of approaches to accommodate diverse learners without academic tracking. All High Tech High International graduates complete the requirements for acceptance into the California public university system.

Personalization

High Tech High teachers practice a learner-centered, inclusive approach that supports and challenges each student. Students pursue their passions through projects, and reflect on their learning. Recognizing that identity development and personal growth occur in the context of community, our schools foster relationships of trust, caring, and mutual respect among students and adults through program design elements such as small school size, small classes, home visits, advisories, and student collaborative work.

Authentic Work

High Tech High school projects integrate hands and minds and incorporate inquiry across multiple disciplines, leading to the creation of meaningful and beautiful work. Students engage in work that matters to them, to their teachers, and to the world outside of school. Students connect their studies to the world through fieldwork, community service, internships, and consultation with outside experts. Our facilities are collaborative workplaces with small-group learning and project areas, relevant technology, and common spaces where artwork and prototypes are created and displayed.

Collaborative Design

High Tech High teachers collaborate to design curriculum and projects, lead professional development, and participate in hiring, while seeking student experience and voice in each of these areas. With students as design partners, staff functions as reflective practitioners, conducting inquiry into equitable teaching and learning, school culture, project design, and authentic assessment. We are all still learning.

School Facility Conditions and Planned Improvements

HTHI is a 29,429 square foot, two-story, high school that occupies a structure originally built in 1967+/- . The building is in excellent condition, with maintenance and custodial services provided by on-site staff. There are no maintenance needs beyond those that are routine for a school of this size. LED lighting and other energy upgrades were implemented in 2016.

As of the school's most recent FIT report, from December 2021, HTHI facilities are considered to be in "exemplary" condition. All of the reported categories (systems, interior, cleanliness, electrical, restrooms/fountains, safety, structural, and external) were rated as "good".

2024-25 Career Technical Education Programs

At High Tech High International the Career Technical Education (CTE) pathway offered is Digital Communications. This pathway provides students with rigorous, hands-on learning connected to real-world careers and are fully integrated into the school's project-based learning model. The Digital Communications Pathway features Digital Media Communications in 11th grade as the concentrator, followed by Digital Video Communications in 12th grade as the capstone. The courses are offered in both honors and non-honors levels and offer students industry grade certifications in Adobe Suite.

All CTE pathways are supported by an active CTE advisory board and strong industry and university partnerships, including Pay it Forward Media, City College Film, Journalism, and Media Production, Sony Pictures. Through these partnerships, students engage in work-based learning experiences such as industry-connected class projects, job shadowing, and 11th grade internships, providing authentic exposure to digital communications career pathways.

High Tech High International's Parent Association has been instrumental in strengthening communication between families and the school and in increasing parent involvement in decision-making that positively impacts student learning outcomes. The Parent Association holds monthly on-site meetings in addition to bi-monthly Java with Jade gatherings. These meetings provide opportunities for parents to learn about specific school programs, ask questions, share celebrations, and raise concerns as

Parents have a meaningful and active voice at HTHI and are offered numerous ways to engage with the school community. Professional Development

Professional development is a core component of instructional practice at High Tech High schools. Dedicated time to refine teaching practice is embedded in each teacher's contractual work year and is delivered through multiple, structured formats.

Staff Days: Returning faculty report to campus multiple days prior to the start of the school year. In addition, teachers participate in five professional development days throughout the academic year and one additional day at the conclusion of the year. These staff days are designed to support collaborative learning and instructional improvement, grounded in the belief that significant professional expertise exists within the school community.

New Teacher Odyssey: Prior to returning teachers coming back to campus, newly hired educators participate in a multi day PD program known as "Odyssey." During this experience, teachers engage in project-based learning as learners by participating in a Project "Slice," a condensed project experience that highlights essential instructional components and practices.

Weekly and Ongoing Meetings: Teachers arrive one hour before the instructional day to engage in collegial dialogue and collaborative professional learning, with meetings occurring at least three days per week. These meetings provide a structured context for both veteran and new teachers to reflect on and refine their instructional practice. Teachers collaborate to analyze student data, plan projects, and address instructional challenges.

As part of the High Tech High charter management organization, teachers also receive additional professional development support through the High Tech High Credential Program and the High Tech High Graduate School of Education.
